- 1) Procurement of Toposheet/OSM Sheet, Cadastral Map, Satellite imagery, Geological Map and their Geo-referencing of the study area.
- 2) Procurement of land schedule for the identification and classification of Land into Forest/Non-Forest/GM Aam/GM Khas/Jungle Jhari/Raiyat etc.
- 3) Identification of a Potential area of minor mineral deposit (Minor minerals mentioned in MMDR Act 1957 as amended).
- 4) Demarcation of area through GPS/DGPS/Total Station Survey considering prescribed Guidelines of SEIAA/NGT.
- 5) Demarcation of blocks with geological field work considering all criteria as mentioned in the WBMMCR,2016 and The Policy of Mining of Minor Minerals of West Bengal in private /Raiyati land ,2022 as amended.
- 6) Water table studies of the demarcated area in line with CGWB guidelines/reports.
