Sub: Termination letter for non-submission of 50 % Annual Sand Premium as H1 Bidder

Ref: Memo No.: MDTC/SAND/003/Part-I/2270 (11/18) dated 01.07.2022

Whereas based on the decision taken by the Tender Evaluation Committee and as per Clause No 8.4.1 in the respective RFP and notice (MDTC/SAND/003/Part-I/1100 dated 12.05.2022) was issued to the H1 Bidders in respect to each RFP for 31 sand blocks for which e-auction were held on 06.05.2022. As per Notice mentioned above, the Training Program on Centralized Online Sand Management System through video conference (VC) was held on 12 Noon the 18th May, 2022.

Whereas as per Memo No.: MDTC/SAND/003/Part-I/2130 (17 / 31) dated 10.06.2022, you were requested to submit 50% Annual Sand Premium amount of Rs. 15,11,30,000/- (Fifteen Crore Eleven Lakh Thirty Thousand Only) within 15 working days. You failed to make the payment within 30.06.2022 as stated in the letter. In addition to that, as per Memo No. MDTC/SAND/003/Part-I/2270 (11/18) dated 01.07.2022 you were given an additional time period within 6 PM of 15.07.2022 for submission of the said amount as a second opportunity. You were also informed the following that in case you fail to pay 50% of the Advance Sand premium amount appropriate action will be initiated against you as per the respective Clauses of RFP as below:

- 1. Forfeiture of EMD as per Clause 8.2.2 (d):
- 2. Termination of the bidder from the list of empaneled operators for excavation and transportation of sand mines to stock-yards / depots, setting up and maintenance of stock-yards / depots, loading sand on the vehicle and sale of sand to end-consumer in the State of West Bengal as per Clause 9.5 (d) and 9.5 (g);
- 3. Non-Acceptance of General Terms and Conditions as per Clause 10.1;

You have once again failed to pay the 50% Annual Sand Premium amount within the specified period.

Thus, as per the clauses mentioned herein above,

- i) The Earnest Money Deposit (EMD) amount of Rs. 6,35,000/- submitted by you vide Demand Draft No.: 333014 dated 18.04.2022 drawn on Axis Bank has been forfeited.
- ii) Your empanelment vide this Office Memo. No.: MDTC/SAND/002/ 1027 dated 30.12.2021 as Contractors for Excavation, Dredging/ Desiltation, transportation of sand mines to stock-yards / depots, setting up and maintenance of stock-yards / depots, loading sand on the vehicle and sale of sand to end-consumer in the State of West Bengal has been terminated and cancelled with immediate effect.
